Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 and its variants are extremely contagious and has significant person-to-person spread. As a result, federal, state, and local governments and federal and state health agencies have recommended social distancing measures and have, in many locations, required ongoing prohibitions and limitations on the congregation of groups of people of various sizes. First Congregational United Church of Christ in Elmhurst has put in place preventative measures to reduce the spread of COVID-19 and any of its variants. These include, but are not limited to social distancing, wellness monitoring, increased sterilization, required hand-washing, etc. However, First Congregational Church of Elmhurst cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the De Colores Camp could increase your risk and your child(ren)'s risk of contracting COVID-19 and any of its variants.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and its variants and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 and its variants by attending De Colores and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 and its variants at the De Colores Camp may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Church and Camp employees, agents, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at First Congregational/De Colores or participation in First Congregational Church/De Colores programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless First Congregational Church/De Colores its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of First Congregational Church in Elmhurst Illinois and its De Colores Camp its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any of First Congregational Church program.
